Our goal is to ship your order within 24 hours. We anticipate orders placed before noon Pacific time will ship the same day. Orders placed after noon, or on Saturdays, Sundays, or holidays, will be shipped the next business day. Transit times depend on the method of shipping and your desired ship-to location. Ground shipments to the northeast may take up to 5-7 business days. Orders for merchandise over \$99 qualify for free UPS Ground shipping.

If for some reason you are not happy with any CLC product purchased from our website, returns are accepted within 30 days of purchase. A Return Authorization is required and freight charges must be prepaid by the sender. The returned merchandise must be in new, resalable condition with the original packaging. On our website select "[Contact \(Contact.aspx\)](#)" and at the beginning of the form select "Return Authorization" from the drop-down menu. In the "Comments" box, please indicate your original order number and the item number(s) that you wish to return (or type in "return all items" if applicable). Upon our receipt of your return, we will notify you and credit you for the cost of the item(s) and tax (if applicable) via the method of your original payment. Original outbound freight charges are not eligible for credit.
